

MEMORANDUM ON STUDENT EXCHANGE
BETWEEN
INDIAN INSTITUTE OF SCIENCE EDUCATION AND RESEARCH PUNE
AND
SCHOOL OF LIFE SCIENCE, THE GRADUATE UNIVERSITY FOR ADVANCED STUDIES

The Memorandum is entered into between Indian Institute of Science Education and Research Pune, India, one party, and School of Life Science, the Graduate University for Advanced Studies, Japan, the other party. Both schools will enter into an Agreement of academic exchange by Indian Institute of Science Education and Research Pune and School of Life Science, the Graduate University for Advanced Studies (hereinafter called "the Agreement").

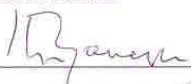
Both parties believe it desirable to confirm and set forth details of the promotion of exchange of students (hereinafter called "student") under the Memorandum.

- Article 1. The period for which exchange students will be accepted shall not exceed one year. This period may be extended for one year only by mutual agreement.
- Article 2. Each of the parties shall annually dispatch and accept not more than five students. Both parties shall make efforts to correct any numerical imbalances in subsequent years. The actual number of students to be exchanged shall be agreed and confirmed in advance by both parties.
- Article 3. Students participating in the exchange set forth herein shall be enrolled as non-degree students at the host university.
- Article 4. The party which hosts the exchange students shall provide the other party with an evaluation of the student's course work at the host university upon the request of the other party. This may be recognized for academic credit at the home university according to its rules and regulations.
- Article 5. Exchange students shall be exempted from any application, admission, or tuition fees at the host university.
- Article 6. Subject to the preceding Article 5, the host university shall not in any way be responsible for student's personal costs, including, without limitation, travel expenses, accommodation fees, living expenses, costs of textbooks and other educational expenses.
- Article 7. This Memorandum remains effective for a period of five years from the later date of the signing indicated below. Its period of validity may be extended by mutual agreement. Either party may, by giving six months written notice to the other party, terminate this agreement during its period of validity. In any case, this Memorandum shall not survive the termination of the Agreement.
- Article 8. This Memorandum is executed in duplicate, both in Japanese and English versions respectively, both of which shall be deemed as originals. In case of any contradiction between the provisions of this Memorandum and those of the Agreement, the provisions of the Agreement shall prevail.

AGREEMENT ON ACADEMIC EXCHANGE
BETWEEN
INDIAN INSTITUTE OF SCIENCE EDUCATION AND RESEARCH PUNE
AND
SCHOOL OF LIFE SCIENCE, THE GRADUATE UNIVERSITY FOR ADVANCED STUDIES

This Agreement is entered into between Indian Institute of Science Education and Research Pune, India, one party, and School of Life Science, the Graduate University for Advanced Studies, Japan, the other party, both universities being convinced that academic exchange and cooperation will promote the development of research and other academic activities in each university.

Article 1. The parties hereto agree to promote cooperation in academic fields of mutual interest through the following:

1. Exchange of faculty members, researchers, staffs, and students
2. Conducting joint research activities
3. Holding lectures and symposia
4. Exchange of information and academic publications

Article 2. Matters pertaining to the implementation of the above mentioned Article 1 shall be negotiated and agreed upon between both parties

Article 3. This Agreement remains effective for a period of five years starting from the later date of the signing indicated below by the parties hereto. Its period of validity may be extended by mutual agreement. Either party may, by giving six months written notice to the other party, terminate this Agreement during its period of validity.

Article 4. This Agreement is executed in duplicate, both in Japanese and English versions respectively, both of which shall be deemed as originals.
