Job Requirements	1] The incumbent is expected to maintain the existing horticultural gardens; prepare plans and execute landscaping in new areas. 2] To supervise the landscaping team and report to the Landscape committee. 3] Planning and supervision of plantation of native tree species on the campus at and their subsequent maintenance.

Eligible candidates who have submitted application on or before **April 03, 2019** by email as above, only shall be considered for the selection process. Date, time and venue of interview will be communicated to the shortlisted applicants by email.

At the time of interview, applicants need to bring application form which was sent to the above email ID, self-attested photocopies of certificates in support of educational qualification, experience, date of birth and in support of information submitted in the application form and one recent passport size colour photograph.

**The applicant must also bring all the original certificates at the time of interview for the purpose of verification.**

### **General Information / details about the post**

1. Appointment is purely temporary and will terminate automatically without any notice or compensation on completion of requirement.
2. The appointed person shall have no claim of appointment / absorption in IISER Pune.
3. The qualification prescribed should have been obtained from recognized Universities / Institutions.
4. Relaxation in age, educational qualification and or experience may be considered in case of exceptionally meritorious applicants, with prior approval of the competent authority.
5. The prescribed Essential Qualifications / Experience indicated are bare minimum and mere possession of same will not entitle the candidates to be called for the selection process. Where number of applications received in response to an advertisement is large, it may not be convenient or possible for the Institute to call all eligible candidates for selection process.
