<b>Preference</b>	Preference will be given to the candidates who have cleared and have valid CSIR/UGC-NET/LS or GATE score cards. Candidates with a high degree of skill in field identification of birds and frogs, and prior experience of working in Arunachal Pradesh, will be preferred.
<b>Fellowship</b>	Starting fellowship of Rs. 12,000/- to Rs. 16,000/- per month + 20% HRA based on academic record and CSIR/UGC NET or GATE score cards.

<b>Tenure of the post</b>	Initially for a period of one year which may be extended subject to satisfactory performance of the incumbent and continuation of the project.
