Preference	The candidate should be well-versed in at least one computer language and be capable of writing code for conducting evolutionary simulations. The candidate should also have some background in wet-lab work related to evolutionary questions. Candidates with good experience of statistics and data analysis will be preferred.
Tenure of the appointment	Initially for a period of one year which may be extended subject to continuation of the project and satisfactory performance of the incumbent.
