- 3. Appointment of the applicant will be governed by the terms and conditions of the funding agency particularly applicable to the said project
- 4. The qualification prescribed should have been obtained from recognized Universities / Institutions.
- 5. Relaxation in requirement of qualification and/or experience may be considered in case of exceptionally meritorious applicants with the prior approval of the competent authority.
- 6. Age relaxation commensurate with educational qualification and experience of the applicant may be considered for candidates having qualification and experience higher than the advertised with the prior approval of the competent authority.

- 7. The prescribed educational qualifications are the bare minimum and mere possession of same does not entitle candidates to be considered in each stage of the selection process.
