<b>Fellowship</b>	Starting from Rs. 12,000/- or Rs. 16,000/- per month + 20% HRA based on academic record and work experience of the candidate and CSIR-JRF/NET or GATE qualification.

<b>Tenure</b>	Initially for a period of one year which may be extended subject to satisfactory performance of the incumbent and continuation of the project.

3. Appointment of the applicant will be governed by the terms and conditions of the funding agency particularly applicable to the said project
4. The qualification prescribed should have been obtained from recognized Universities / Institutions.
5. The prescribed educational qualifications are the bare minimum and mere possession of same does not entitle candidates to be called for interview.
