### MEMORANDUM OF UNDERSTANDING

This memorandum of understanding is made at Pune on Monday, the 15<sup>th</sup> November 2010.

### BETWEEN

Indian Institute of Science Education and Research, Pune an Institute established by the Ministry of Human Resource and Development (Hereinafter referred to as "IISER" Pune)

### AND

Bhaskaracharya Pratishthana, a Research Institute in Mathematics registered under the Societies Registration Act (MAH/1127/(POONA)/(F-967) established in the year 1976 and situated at 56/14, Erandavana, Damle Path, Pune 411004 (Hereinafter referred to as "BP")

Whereas IISER, Pune is an Institute of National importance that imparts Education and carries out Research in the fields of Mathematics, Physics, Chemistry and Biology


And whereas BP is a Research Institute in Mathematics affiliated to University of Pune as a Research Centre

And whereas BP undertakes various academic activities in Mathematics for students and teachers in schools, colleges and other academic institutes

And whereas IISER, Pune and BP desire to enter into a Memorandum of Understanding for the purpose of conducting joint activities related to Education and Research in Mathematics (Herein after referred to as "Activities")

It is mutually agreed by and between the parties as under "Activities" would mean

1. Seek mutual advice and support in planning and executing programs promoting excellence in Mathematics education and research.
2. Encourage the regular faculty members and visiting faculty members of either institute to visit the other Institute for giving talks in Lecture Programmes, Workshops, Seminars and Conferences in Mathematics.
3. Encourage students of either Institute to attend lectures in the other Institute during lecture sessions, seminars and conferences.
4. Share the library facilities mutually by giving access of library of either Institute to students, faculty members and visitors of the other Institute.
5. Share computer/other facilities of either Institute to students and teachers of other Institute for academic work.
6. Share as per mutual convenience facilities like guest house for visitors and hostels for students.
7. Share video conferencing facilities as per mutual convenience for educational purposes.
8. Encourage the research/graduate students of either Institute to visit the other Institute for short durations for getting research inputs and guidance upon recommendation from the research guides/faculty members.



9. Encourage guidance for students of either Institute in academic projects by staff members of the other Institute.

10. Encourage joint research activities and projects by the faculty members of BP and IISER.

There will be a coordinating committee consisting of the Directors of IISER, Pune and BP and two additional members from each Institute who will be responsible for the effective implementation of the MOU.

If any charges/expenses are to be paid by either Institute for the facilities provided by the other Institute, such will be decided by the coordinating committee from time to time as per need. The charges for facilities such as Guest House and Lecture Halls that are to be provided by either Institute to the other institute, if any, would be at the official rates.

The courses offered by each institute will be recognized by the other institute towards credit requirements for various programmes.

This MOU is valid for five years from the date on which it is signed.
