#### **Prologue**

A press tender notice on Expression of Interest (EOI) was published on 8<sup>th</sup> January 2022 for establishing a BSL3 laboratory at IISER, Pune. The notice was also published on the Institute website and CPP portal of Government of India on 06<sup>th</sup> January 2022.

In this regard, a Pre-Indent EOI meeting was held on Thursday, 27<sup>th</sup> January 2022 from 2 pm onwards at IISER Pune virtually via Zoom with the prospective manufacturers, their authorized channel partners or agents/suppliers and system integrators to discuss with the Technical Committee on the aspects of utility, technology, feature, literature, design, technical parameters, clientele and other related issues for establishing a BSL3 laboratory at IISER Pune.

Attached is a list as **Annexure A** with details of the 12 prospective manufacturers that attended this EOI meeting.

#### Brief on the meeting:

All participants were informed before the meeting to present their companies portfolio and expertise on the aspects of utility, technology, design, technical parameters, clientele and other related issues (e.g. guidelines followed) towards establishing a BSL3 laboratory. They were all given 10 mins to present this information, following which the technical committee would ask them questions (if any) or clarifications based on the presentation.

Following the presentations and the discussions post the presentation, the technical committee found that several of the participants lacked any experience or necessary expertise in building BSL3 facilities. Additionally, several participants had no experience and/or knowledge of installing or providing IVC facilities for the proposed rodent studies in the BSL3, or building laboratories for infectious pathogens (e.g. MTB or viruses). A few vendors were also not aware of the revised RCGM-DBT guidelines that is now mandatory for building such facilities in India. These were the complex yet overall integrated criteria the technical committee considered while shortlisting participants to invite for the tendering process, as these would be the institute's requirements in establishing a state of the art BSL3 facility as a turnkey project with a 5 year CMC complete with validation and certification.

### Recommendations:

In view of the above criteria, the technical committee recommends to:

- A) Invite only the following vendors (see **Annexure B**) for the limited tendering process in establishing this BSL3 facility at IISER Pune:
- 1. CSK Projects
- 2. Integrated Cleanroom Technologies Pvt. Ltd.
- 3. Biosafe Lab India Pvt. Ltd.
