Necessary manufacturing certificate proof should be also attached for claiming exemption*</http:>	The Bidders registered under MSME shall be exempted to pay EMD and tender fee. However, they must upload scan copy of registration with MSME in appropriate category related with work to claim exemption. If self-attested copy registration as mentioned above is not found in the documents uploaded by bidder, then bid of the said bidder will be rejected Summarily.
2	Technical specifications: 1) Size: 3840 x 2160mm (+/-10% variation) should be allowed so that all OEMs can participate, please make bidding open for all, this single size only restricts this bid to very few OEMs. Request to take action as per GFR rule against restrictive bidding.	Bidders shall note that size of LED wall is defined considering pixel pitch P2 (2mm) Hence there is no change in Size of LED wall.
3	Frame & LED Display should be front maintenance, for ease of maintenance. Since all the latest Indoor fixed installations are installed with magnets for ease of maintenance hence request to please amend.	Bidders please note that , there is no change in technical specifications.
4	Addition of certifications: BIS, CE, FCC, ROHS, EMC, EMS, ISO, UL, etc. so that industry level parameters can be maintained.	Bidders please note that , there is no change in technical specifications.
5	Removal of point: Enlistment order of the contractor (attested copy): We would like to inform you to please refer to GFR Rules on restrictive bidding, this above clause is leading to restrictive bidding. We request you to kindly remove the same & practice transparent process. It is to mention that there is a continuous effort to make this bid restrictive & cartelized. This way reputed OEMs or other bidders having prior experience will be rejected. Please remove this point & make the bid participable for all.	Bidders please note along with registrar contractor or specialized agency like OEM/dealer/suppliers are already allowed to participate in the bidding.

Removal of Shop Act Licence: *
Sir we would like to inform you that this license is not applicable
to us & many OEMs, hence we request you to remove the same
over priority since this will restrict the bidding which is against
GFR rules.

Bidders please note that OEM registered with MSMED or register under company act shall submit registration scan copy of the same. However dealers/supplier shall submit scan copy of shop act license.
