1	Can we file as a consortium of sister concern companies?	Yes, bid can be submitted as JV. However registration shall be done by one of the consortium member only, and that registered firm only will be considered for the entire process.
2	One of our sister concern companies is in process of merger with another sister concern companies, can we submit "board resolution" to that effect?	No, bid cannot be submitted on the basis of "Board resolution" by the sister concern company.
3	As indicated by you, exemption of EMD is applicable to MSME entity provided due certificate is submitted. Kindly clarify if exemption is also applicable re tender fees.	Yes, exemption is applicable to tender fee.
4	We note that financial quotes have to be submitted including GST, however, under reverse charge mechanism GST is to be paid by Recipient. Hence in our case (Sole Proprietorship Firm) GST is not deposited by the Law Firm. In this scenario, kindly confirm if we may quote charges without including GST.	Yes, under reverse charge mechanism GST is to be paid by Recipient. Hence, please quote without GST. Mention in the document clearly the costs exclude GST.
5	With regard to requirement of submitting client certificate(s) having at least 5 years of experience in providing IP services to Central/State Government related organizations, no specific number of Certificates from such government clients have been indicated to be submitted in the bid document. If there is any specific number of government client certificates required, kindly advise.	Bidder may submit atleast 3 client certificates they wish to submit substantiating their claim of 5 years of experience in providing IP services. The certificate to be obtained on client

6	Kindly let us know the full form of "IDS" as mentioned in page 2 of "Proforma for evaluation of technical performance of the tendering agency/firm/company". We understand it as the Information Disclosure Statement,	IDS is Information Disclosure Statement.
7	however want to confirm this understanding with you. For the technical evaluation, the bidder is required to submit the number of IP filings and grants in India and abroad in the last 3 years along with supporting documents. As per our understanding, the supporting documents are: 1. POA 2. Filling Receipts 3. Filling Instructions sent to our Foreign Associates (for filing applications abroad).	For Granted patent outside India, provide a tabular summary of granted foreign patent details including foreign attorney IPR firm details, filing instructions of Indian IP firm sent to foreign attorney firm. Submit patent registration certificate as supporting document.
