**3. Provision of contact details:** The bidder should have provided Patent Management software solution to at least two customers in India during the last three years. Necessary documentation proof such as work orders/purchase orders along with the letter from end-user of satisfactory usage is mandatory, without which the bid shall be considered ineligible and summarily rejected,

**4. Demonstration of Product/Software:** Before the final award of contract the successful bidder has to give an access to its software and has to provide a demo module to test the performance and available user interface.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
