LC Payment will be done offline and updated through bulk update on GeM. **OR** Payment will be made directly to the suppliers by RTGS after receipt and the acceptance of the material at IISER.

12. Fall Clause:

The Bidder undertakes that he has not supplied/is not supplying the similar systems or subsystems at a price lower than that offered in the present bid in respect of any other Education/ Public Sector Undertakings/Public sector undertakings/Ministry of Education and if it is found at any stage that the similar system or sub-system was supplied by the BIDDER to any other Education Public Sector Undertakings/ Public Sector Undertaking/Ministry of Education at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER to the BUYER, if the contract has already been concluded.
