## PRE-BID CONFERENCE FOR ITEM DESCRIPTION- PROCUREMENT OF NETWORK COMPONENTS

S. No.	Query/Clarification Sought	Clarification / Amendment
1	The bidders are required to submit a declaration for local content (Class I or Class II). However, the bid technical compliance demands compatibility and compliance with existing setup i.e., Cisco C9200 switches and WLAN Cisco 5520. Requested to provide waiver for MII clause.	The requirement pertaining to the declaration of local content (Class-I/ II) for the products chose to bid is in line with the Public Procurement (Preference to Make in India) policy notified vide O.M. No. P-45021/2/2017-PP (BE-II), Public Procurement Section, DPIIT, Ministry of Commerce and Industry, Govt. of India dated 16.09.2020 with all it's subsequent amendments; which bidders are required to comply with. It is also clarified that the proposed procurement intends to acquire the network equipments / components which are fully compatible and integrable with the existing working network infrastructure of the institute comprising of Cisco make network Access / L3 / core / Distribution Switches and Cisco make WLC with 350+ working access points. Hence; the requirement prevails.
2	In case bidder submit multi brand solution; is it mandatory to submit OEM authorization from all OEM's?	Yes, Please.
3	Is there is possibility to float separate bid in the future for Network integration scope of work?	Refer clause 4 of the Scope of Work published in the bid document, reproduced as below:  "Actual site installation and configuration shall be taken up separately by the institute (not included within the scope of this tender) at it's convenience."
4	Scope of work - states that installation will be taken up by the institute and hence it's not under supplier's domain. However, payment of 10% is linked to the completion of	sub-clause # 11, Payment Terms' is amended as below:

	satisfactory installation and commissioning. This should be reconsidered (Ref: Buyer Added Bid Specific Terms and Conditions, clause # 8, sub-clause # 11, Payment Terms).	Payment shall only be made post completion of the 'Scope of Work' as described in the tender document, submission of warranty certificates and upon receipt of Bank Guarantee for 5% of total Order value towards performance security (valid for 2 months beyond the prescribed warranty period of 12 Month; i.e. for 14 months ).
