1	Requested to share the CAD Layout of the actual Site to help us understand the equipment placement and validate the required cable lengths for installation	CAD diagram shall be shared with the successful bidder as per the requirement. The vendors are encouraged to perform the site visits before quoting.
2	For the 160-seater room, a 1x4 splitter is considered; however, since we only have 2 outputs, can we quote for a 1x2 splitter instead? Please advise.	1 Additional HDMI port had been provisioned (over and above the required two) for recoding the contents (as and when required). Hence, the tender specification remains unchanged.
3	For the 160-seater room, there are 6 USB-C to HDMI converters considered. Could you please clarify why 6 units are necessary when we only have 1 wall plate for connectivity.	These are standard accessories (extra) to be supplied with the installation. Not all of them to be directly integrated with the system supplied. No change in tender specifications
4	For the 100-seater room (which can be divided into two rooms of 50 seats each), is there a Single Line Diagram (SLD) prepared? This would help us validate the design specifically for this room. Based on the Bill of Quantities (BOQ), we believe an additional 20 meters of cable may be required. Please advise."	SLD is not available. IT is clarified that the two rooms are to be independently operated (in regular operation) with a set each, of Video projection system (Projector + Screen) and audio systems. In a rare case, these rooms will have to be interconnected by a HDMI cable for display mirroring and audio patching cables for sound reproduction across the rooms (This entire process shall be manual and no Audio / Video or matrix switcher had been proposed). The length of HDMI cable and quantity has been factored in as per the actual site requirement in the BoQ. No change in tender specifications



5	For the 160-seater room, there is currently no antenna system considered for the wireless microphones. Could you please advise if the receiver will be in line of sight with the transmitter? Additionally, if we could obtain the CAD drawings, we would be able to provide suggestions regarding coverage.	The Microphone receivers are to be placed in the same room and equipment rack shall always be in the line of sight. Standard implementation should work without any additional diversity antenna. The bidders may ensure that the selected product has an appropriate antenna gain at the receiver itself. No change in tender specifications
6	This is common for all rooms: the projector has an audio output. Can we take the audio directly from the projector? This would eliminate the need for a de-embedder. Please advise.	No change in tender specifications. Audio from the projector shall not be sufficient for a typical fully occupied room.
7	160 Seater computer Lab, for 12U Rack, 172 LAN ports termination, Required patch panels will be IISER scope or supplier scope?	The bidders to supply the fully loaded Cat-6 patch panels. Refer: Tender Document -- Special Condition of Contract -- Facility -01 -- line item 20. No change in tender specifications
8	MAF Format not available in Tender document. Kindly confirm if MAF is Required.	Manufacturer Authorization is not required. However; upon completion of the project, the contractor has to mandatorily submit the warranty certificates for each electronic item from it's OEM / Screenshot of the OEM portal depicting it's warranty as prescribed in the tender document (which shall be individually verified). No change in tender specifications.
