The bids are invited from a local supplier as per Department for Promotion of Industry and Internal Trade, Ministry of Commerce and Industry Order No. P-45021/2/2017-PP (BE-II) dated 04 June, 2020

**Class - I Local supplier** - whose goods offered for procurement has local content equal to or more than 50% as defined below:

**Class - II Local supplier** - whose goods offered for procurement has local content more than 20% but less than 50% as defined below

**Local content:** Means the amount of value added in India, which shall, unless otherwise prescribed by Nodal Ministry, be the total value of item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all custom duties) as a proportion of the total value, in percent.

The above bidders are required to indicate percentage of local content and provide self-certification the items offered meet the local content requirement for Class -I Local Supplier /Class - II Local Supplier as the case may be. Further the bidders shall also give details of the location(s) at which the local value addition is made.

False declarations will be in breach of the Code of Integrity under Rule 175(1)(i)(h) of the General Financial Rules 2017 for which a bidder or its successors can be debarred for up to two years as per Rule 151 (iii) of the General Financial Rules along with such other actions as may be permissible under law.

A supplier who has been debarred by any procuring entity for violation of above cited order shall not be eligible for preference under above Order for procurement by any other procuring entity for the duration of the debarment.

### TERMS AND CONDITIONS FOR SUBMISSION OF QUOTATION

1. Quotations will be accepted only from manufacturers or they may authorize only one exclusive agent against Tender Enquiry No IISER/PUR/0229/25, who may quote along with authorization valid as on date of submission of bids. Authorized Agent quoting for the supply should attach authorization from the manufacturers, failing which the quotation will be summarily rejected.
2. IISER Pune may at its discretion accept bids of any non-local bidder provided the same is required for any equipment/specialized consumable available in the institute and substitutes available in India are not suitable for the purpose. Each order for such bidder shall be processed only if the concerned user certifies about the same.
3. The bidder may please note that the RC is only for consumables. Any bidder sending any proposal for non-consumables shall not be accepted.
4. An undertaking must be submitted by the bidder, with the tender document, that the product offered for rate contract are not uploaded on GeM portal. If some products of catalogue are offered on GeM, a list of such items (which are available on GeM) must also be furnished with the tender or the same must be mentioned/highlighted/star marked in the pricelist

6. The Rate Contract will be valid for a minimum period of one year and further extended up to 2 year subject to approval of competent authority. The Prices offered shall be valid for a period of One year from 01 Sep 2025 to 31 Aug 2026; there will be no additional charges for delivery. The Delivery will be FOR IISER Pune on Free of Cost basis.
7. The Bids should be complete in all respects and should be duly signed. Incomplete and unsigned bids will not be considered.
8. There shall be no change in price structure during the currency of contract except of the statutory levies which are made applicable by the Govt. through notifications and regulations. However, the Bidder will pass on the advantage to IISER Pune in case of downward price movement during the Contract period.
9. List of Other Similar Organizations where similar supplies have been made and having a Rate Contract may be submitted.
10. Prices charged for the stores supplied under Rate Contract should under no event be higher than lowest prices at which the party sells the items to any other organization during the period of contract.
11. The rate contract will be guided by “Fall Clause”.  
*“if the rate contract holder reduces its price or sells or even offers to sell the rate contracted goods following conditions of sale similar to those of the rate contract, at a price lower than the rate contract price, to any person or organization during the currency of the rate contract, the rate contract price will be automatically reduced with effect from the date for all the subsequent supplies under the rate contract and the rate contract amended accordingly.”*
12. The goods will be delivered within 4 weeks of placement of order or as agreed.
13. If the supplier fails to deliver the material within the delivery period as specified, IISER Pune may procure such items from alternate source. The supplier will be liable to the purchaser for any excess costs incurred for procurement of goods or services not delivered in time.
14. Replacements - Damages/Broken/Expired or any other reason which renders the goods of use to IISER Pune will be replaced within a weeks’ time at no cost to IISER Pune.
15. IISER Pune also reserves right to test the chemicals and solvents of material for their quality if it so desires, if the items supplied is found to be of inferior quality and grade the same will have to be replaced by the supplier at their cost within the stipulated time period.

16. Payment Terms - Our Payment terms are normally within 30 days of receipt and acceptance of goods at IISER Pune. Payment will be made by NEFT. No Advance Payment will be made under any circumstances.
17. Relevant Certificates for purpose of availing Custom Duty and GST exemption in terms of Notfn. No 51/96 Customs dt 23.07.1996, Notfn. No. 47/2017 Integrated Tax (Rate) dt 14.11.2017 and Notfn No.45/2017 - Central Tax (Rate) dt 14.11 2017, as amended from time to time will be provided by the institute.
18. IISER Pune is entitled to place orders up to the last day of the validity of the rate contract and, though supplies against such purchase orders will be effected beyond the validity period of the rate contract, all such supplies will be guided by the terms and conditions of the rate contract.
19. IISER Pune will not be liable for any obligation or supplies made unless the Official Purchase Order has been placed by the Purchase Department.
20. IISER Pune and/or the firm are entitled to withdraw/cancel the rate contract by serving one-month notice on each other. However, once a purchase order is placed on the supplier for supply of a definite quantity in terms of the rate contract during the validity of the rate contract, that purchase order becomes a valid and binding contract
21. IISER Pune does not guarantee or assure of any quantum of business during the contract period. The order will be issued only if the requirement of such items arises in the Institute.
22. All disputes of any kind arising out in connection with the executing the order shall be referred by either party (IISER, PUNE or the bidder) after issuance of 30 days' notice in writing to the other party clearly mentioning the nature of dispute to a single arbitrator acceptable to both the parties. The venue for arbitration shall be IISER, PUNE India. The jurisdiction of the courts shall be Pune, Maharashtra, India
