- 3. Bidders technically disqualified shall be intimated.
- 4. The Financial bids of only those tenderers will be opened who are declare d qualified by the Technical Evaluation Committee. If tenderer quote less than 3.85 /NIL charges / consideration, the bid shall be treated as unresponsive and will not be considered. In case of multiple L1 bidders against this bid, the Instit ute will use the 'Run L1 selection', which is GeM portal feature wherein the syst em randomly identifies an L1 seller. It works on pseudorandom number genera tor algorithms, which is the system generator based on linear congruential algorithm.
- 5. The bidders are required to quote Administrative charges inclusive of GST . Nothing over and above contract value shall be paid in any circumstances.
- 6. Telegraphic, conditional or incomplete tenders will not be accepted. Canv assing of any kind, direct or indirect, shall lead to disqualification of the tender er.
- 7. Tender in any form other than the prescribed form issued by IISER Pune s hall not be considered and will be summarily rejected.
- 8. Earnest Money Deposit (EMD) of Agency / Firm / Company who withdraws tender during the intervening period shall be forfeited.

SPECIFIC TERMS AND CONDITIONS

- 1. Bidders should have applicable licenses from State/Central authorities.
- 2. Agency must fulfill all the requirements given in the Technical Bid and terms and conditions of the tender.
- 3. Photocopies & supporting documents submitted on GeM Portal should be legi-
- 4. Initially Letter of intent will be issued to successful tenderer. On receipt of per formance bank guarantee and security deposit institute will issue work order and agreement.
- 5. Within 30 days from the date of issue of the award of contract, Contractor will apply to the Labour Commissioner for obtaining a labour License and will sub mit a copy of license to IISER Pune. It will be the responsibility of the contract or to renew it on time and also obtain fresh license as per requirement whene ver number of contractual employees are increased beyond the given numbe r.
- 6. The manpower proposed to be deployed by the Contractor shall be subject to screening by the Institute to ascertain their suitability and skills. Further, man power to be deployed shall be at the mutual consent and discretion of the Institute. Before deploying a staff in the Institute the Contractor shall furnish com plete particulars and obtain written approval of the designated Official of the Institute.
- 7. The Director, IISER Pune shall have absolute right and authority for the suspension/revocation of security/bank guarantee in case of breach of any clause of the Agreement by giving prior notice.
- 8. The decision of the Director, IISER Pune with regard to the determining of quality of work/services done by the contractor or his employees shall be final a nd acceptable to the contractor. The Director, IISER Pune reserves the right to get the work/services so rejected done/replaced at his own level at the risk and cost of the contractor after giving him a notice in writing and the expenditure incurred on this count shall be recovered from the contractor from his outstanding dues or by revocation of any or all parts of the security/bank guarantee, as he may think proper.
- 9. The Contractor will ensure that his contractual employees are medically fit an different from communicable disease.
- 10. The Director, IISER Pune or any other officer(s) so authorized by him shall be at liberty to carry out any surprise check on the working of the employees so deployed by the Contractor in order to ensure that the required numbers of employees are deployed and that they are doing their duties satisfactorily.
- 11. The manpower deployed by the Contractor for the execution of the contract s

- hall be the employees of the contractor for all intents and purposes and in no case, there shall be any relationship of employee and employer between the said persons and the Institute either implicitly or explicitly.
- 12. The contractual employees so deployed shall be under the overall control an d supervision of the Contractor and the contractor shall be liable for payment of their wages etc. and all other dues within the stipulated time which the Contractor is liable to pay under the various Labour Regulations and other statutory provisions. IISER Pune shall be absolved from any such liability at its own level.
- 13. Contractor will also facilitate opening of salary account of all contractual staff at State Bank of India, NCL Branch for payment of salary.
- 14. The Contractor shall be responsible for all injuries and accidents to Persons e mployed by it. Contractor will also cover, through an Insurance Policy, its personnel for personal accident whilst performing the duty at his own cost.
- 15. The contractor will submit wage bill as prescribed by IISER Pune: -
- Wage bill has been generated as per the attendance record maintained on sit e.
- Deduction Schedule showing the individual details of deductions of EPF, ESI to be tallied with the wage rate.
- The contractor will raise bill for all contract workers once in a month no supple mentary bill will be submitted thereafter.
- No person(s) has/have been engaged on contract basis in this Institution without the prior approval of the competent authority.
- Following documents needs to be submitted along with the monthly wage bills
 - a. Copy of bank scroll / bank challans as a proof of deposit of salary for the month.
 - b. System Generated challans & ECR for payment of employee / employer contribution to EPF, ESI etc.
 - 16. Contractor shall pay GST, at the rates as applicable from time to time.
 - 17. Contractor shall pay wages to all its staff on last working day of the month. S chedule of process to be followed is as under:

- 18. The Contractor shall conform to the provisions of various Central/State Act(s) or the Regulations on the subject as well as terms and conditions of the contract. He will be liable for the deduction of TDS on the total bill as per provision of the Income Tax Act, or as applicable from time to time.
- 19. Price bid should not be quoted with Technical Bid, otherwise the ten der will be rejected without any correspondence.
- 20. Security Deposit: The successful bidder should deposit a security de posit of Rs. 2,00,000/- (Rupees Five Lakh Only) as an interest-free de mand draft in favor of "Director, IISER Pune" within 15 days of the d ate of the letter of intent. This deposit will be held for the duration of the contract plus two months.
 - a. The deposit is intended to cover the cost of uniforms to be provided by the Contractor to its contractual employees deployed on site.
