6. Any breakdown in the equipment needing repair at your workshop you have to inform the same in writing to us.
7. The rates quoted above are inclusive of visit charges and to & fro local conveyance expenses, lodging & boarding expenses.
8. All Hardware Spares will be provided for repair including consumables for repair.
