Any cylinder failing independent laboratory testing will be immediately rejected with no payment. The vendor must replace rejected cylinders within seven (7) days at their own expense. In addition to losing payment for the rejected cylinders, a penalty equal to 10% of the cylinder cost per incident will be deducted from pending bills or the Performance Security.

1.1 Repeated Non-Compliance & Debarment: If the supplier fails to meet purity requirements on **three (3) separate incidents** despite corrective actions, the purchaser reserves the right to terminate the contract, forfeit the Performance Security, and initiate debarment/blacklisting.
