For all the above 5 bids; upon assessment of the proposals received pertaining to the technical aspects based on the documents submitted by the bidders, below are the findings:

The Technical Bids of the following bidders were found to be deficient on the grounds mentioned below:

1. Progility Technologies Pvt. Ltd. (Bid No. 1590890)



- Noncompliance to the technical tender specifications (As declared by the bidder in the submitted Annexure B):
 - i. Subsection A: Point Nos.- 2,4,6,8 & 9.
 - ii. Subsection B: Point Nos.- 10 & 11.
 - iii. Subsection C: Point Nos. 9 & 10.
 - iv. Subsection G: Point Nos. 8, 9 & 10.
 - v. Subsection H: Point No. 7.

2. Arvind Limited. (Bid No. 1590890)

- AMC Certificate (Annexure-H) submitted blank
- Solvency Certificate submitted is more than 12 months old
- Noncompliance to the technical tender specifications (As declared by the bidder in the submitted Annexure B): i. Subsection A: Point Nos. 5, 6 & 9.

3. Nectar Infosystems Pvt. Ltd. (Bid No. 1592926)

- Unpriced BoM submitted without the required details.
- No information was provided regarding the compliance to the bidder eligibility as described in 'chapter - 2 Bidder's eligibility criteria, Page No -11, Point No. 5' which primarily mandates the bidder to have a technical support center at Pune for provision of 100% system support services.
- Noncompliance to the technical tender specifications (As declared by the bidder in the submitted Annexure B):
 i. Subsection A: Point No- 9.

4. AV Link Technologies Pvt. Ltd. (Bid No. 1593166)

- Solvency Certificate not submitted.
- Disagreement to the commercial tender specifications (As declared by the bidder in the submitted Annexure A): Point Nos: 4b, 5a, 13, 16, 20a, 20b, 21.

5. SRSG Broadcast (India) Pvt. Ltd. (Bid No. 1594103)

- Annexure B Compliance to the technical specifications not submitted.
- Solvency Certificate not submitted.
- No information was provided regarding the compliance to the bidder eligibility as described in 'chapter - 2 Bidder's eligibility criteria, Page No -11, Point No. 5' which primarily mandates the



bidder to have a technical support center at Pune for provision of 100% system support services.

Thus after reviewing the proposals received for the technical aspects based on the documents submitted by the bidders the findings are summarized as under:

1. None of the received bids are found to be substantially responsive to the requirements of the Tenders Documents. Hence; as per GFR 2017 In view of the above. (Goldi Musia) sayrous ground from tender with same specifications. rule 173 (xix) all the bids are declared "Technically dis-qualified".
