Terms and Conditions:

- 1) The applicant should be eligible contractors registered with anyone CPWD, Maharashtra State PWD, Railways, MES in appropriate category of Civil/Composite/Furniture Category or dealer or Manufacturer of curtain brackets. Applicant should submit attested or notarized copies of the valid Registration Certificate / Experience Certificate/Work order along with the quotation. Bidders not meeting the minimum eligibility criteria shall be summarily rejected.
- 2) Time period for completion of work shall be 30 days from the date of placing the work order by IISER Pune. The act of backing-out after opening of quotation will debar such agencies for participating in the future quotations of IISER PUNE. Bidder may e-mail queries on maintenance@iiserpune.ac.in or submit to IISER PUNE office in hard copy on all working days one day before submission date of quotation as specified above.
- 3) Notice Inviting Quotation (NIQ) document may be obtained from IISER PUNE at 121, Engineering Section , Main Building, IISER PUNE Campus, Dr.Homi Bhabha Road, Pashan, Pune-411008 between 10 AM to 4 PM on all working days before date of submission. 
- 4) All agencies need to submit their quotation in hard copy in sealed envelope containing by suitable means on and before **3 PM on 3/11/2020**. Quotation received after the date & time specified above shall not be accepted. Any delays , postal delay etc. will not be entertained. Agency should quote for all the items in the in the BOQ . Rates quoted in words shall be treated as Final for deciding L1 bidder. The bid shall be submitted in the original bid document (as issued by the IISER, Pune or Webcopy) super scribing the name of work. Quoted rates shall be valid for 60 days from the date of opening of quotations. Rates shall be quoted in hand writing at the spaces provided in NIQ document. Commercial envelops of technically qualified bidders shall be opened accordingly. The offer of the agency should be commercially clear including acceptance of all terms and conditions of this Quotation by the agency. IISER Pune reserves the right to accept or reject the quotation/s without assigning any reasons. Engineer In-charge decision about item-wise or overall L1 bidder/s shall be final.
- 5) Bids will be opened **on the same day at 3.30 PM** in the presence of agency or their authorized representatives, if any. Quotations submitted with any conditions shall be treated as conditional quotations and shall be summarily be rejected by IISER PUNE.
- 6) Quoted rates should be inclusive of cost of all the materials, labour cost , GST ,all taxes, royalties, cost of fuel, operator , octroi , duties , cost of sample and fees towards testing of materials in labs ,royalties etc. complete. Nothing extra shall be paid separately. No, Bidder shall contact the IISER, Pune on any matter relating to his bid from the time of the bid opening to the time of issue of work order. Any effort by the Bidder to influence the IISER's bid evaluation, bid comparison or contract award decisions, may result in the rejection of his bid. Decision from competent authority/Engineer In-charge shall be final and binding to bidder in all the matters relating this work.
- 7) All approved makes shall be as specified in BOQ and as per CPWD specifications, agency should put-up technical data and obtain prior approval on makes of various materials of IISER PUNE before taking-up work. The successful agency shall make his own arrangement for all Tools & tackles for work etc complete in view of completion of work. Electricity shall be provided free of cost to agency at one source, agency should make own arrangement to safely tap of power from source to work location. Any scaffolding required shall be brought by contractor to complete the work with no cost to IISER Pune. Lowest bidder to furnish water proofing guarantee as per CPWD SOP on Rs.500/- bond paper.
- 8) No advance payment shall be made by IISER Pune. Quoted rates should be including GST , TDS and other applicable taxes . Income Tax and labour cess will be deducted from the bills of the work.

- 9) Specification for the work to be carried out as per BOQ, latest CPWD specification, IS specifications & as per instruction of IISER PUNE whenever specification CPWD/ IS specification are not available.
- 10) The contractor shall ensure that minimum wages should be paid to the labours and employees in accordance with labour laws. All the safety measures shall be followed by the L1 agency as per prescribed norms during execution of work with all the necessary safety tools etc. Executing Agency shall be sole techno-commercially responsible for the strict adherence of safety norms and allied compensations etc.
- 11) Agency should submit measurements and abstract sheets to IISER PUNE for the payments within 30 days from completion of work.

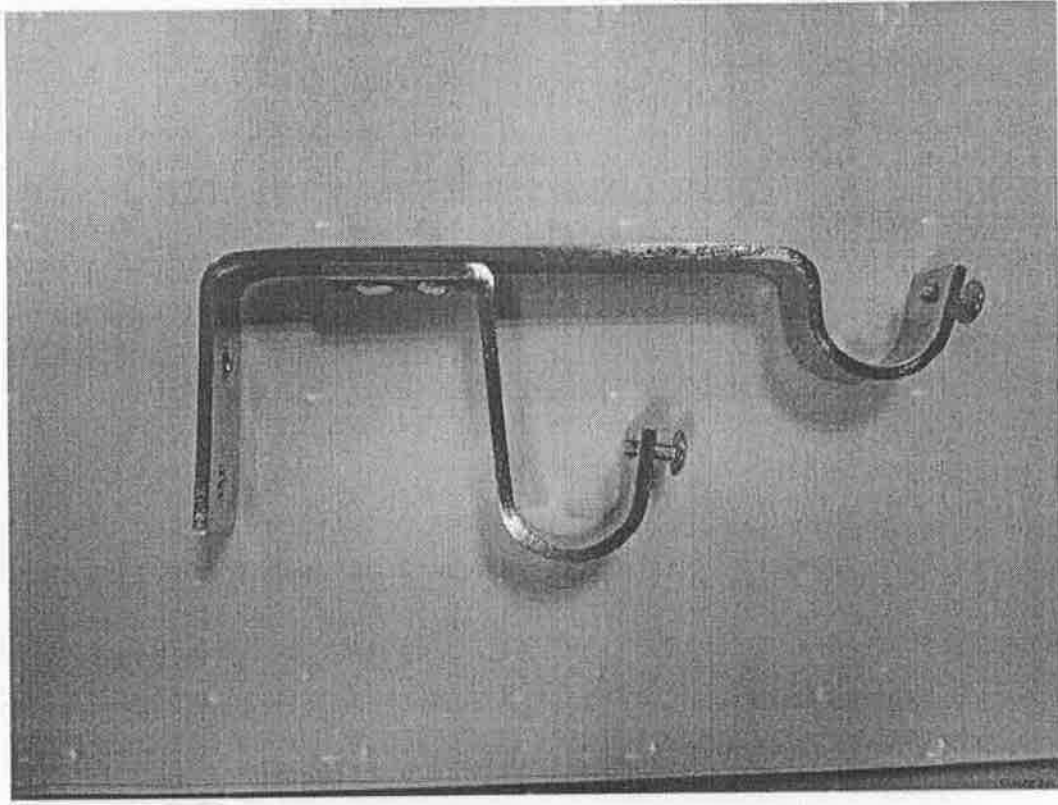
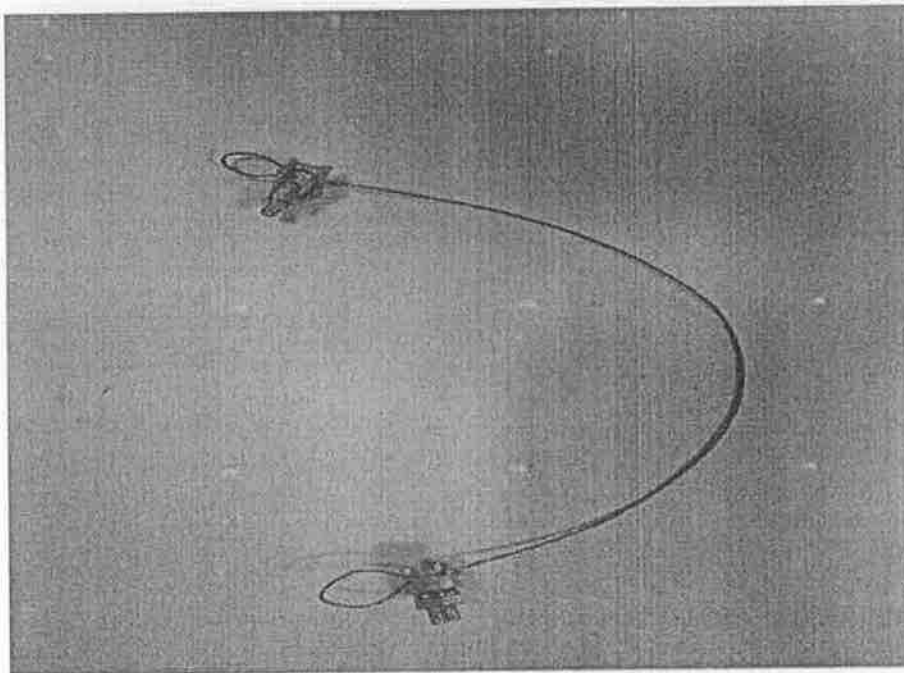


Image of anti-fall guard 2mm wire rope : For approved shape and size

Name of work- Providing and fixing curtain bracket to housing A, B and D Building at ISER Pune.


Sr.	Description	Qty.	Unit	Rate in word and figures	Amount
1	Providing and fixing half round single length stainless steel finish curtain bracket including removing of exiting fittings. curtain bracket shall be double rod holder bracket with overall length of 170mm long. Bracket shall be factory made in stainless steel flat of 20mm wind and 5mm thick made-up at factory in approved shape. Single piece curtain holder shall be made in single piece jointless flat and second curtain rod holder shall be screwed on single piece assembly. Wall side holder of single piece bracket shall be of 60mm right angle bend. Overall weight of one two holder bracket shall be minimum 225 grams each. One flat headed stainless steel screw shall be provided with curtain holder to hold curtain rod in position. During installation curtain rod positioning screw shall be tightened inside one wall of curtain rod to avoid slippage of rod from holder by making hole to existing curtain pipe etc as per direction of Engineer etc complete. Curtain brackets shall be fixed as per clearance issued by occupants in phase wise manner in flats of housing building at A, B & D building. Overall curtain bracket design should be as per attached image. Quoted rate shall cost of labour, material, lead, lift, transportation, removal of existing fittings, re-fixing of curtain rods, safe and dirt-free removal of curtains and re-fixing of curtains, GST, cost of 75mm long stainless steel screws two for each bracket, GST etc complete. Nothing extra shall be payable separately. (as per reference image)

2	Providing and fixing anti-fall guard made-up of stainless steel flexible wire rope of 2mm thick, 300mm long with one end fixed on the wall with hook type screw assembly and other end roped with both curtain rods at each bracket to act as fall guard of curtain rods. Assembly shall be capable of taking weight of curtains along with rods upto 25Kg. Quoted rate shall cost of labour , material , lead , lift , transportation , stainless steel screw , hook , wire rope locking fitting 2 numbers , GST , cost of 75mm long stainless steel screws two for each bracket , GST etc complete.
