A press tender notice was issued on 15th June 2013 for the procurement of Compact inverted microscope under two-bid system.



S.No	Query/Clarification Sought	Clarification / Amendment
1.	Page 23, Section Illumination & Filters. Are high luminescent LED lamps required for fluorescence and brightfield applications?	High luminescent LED lamps are required only for fluorescence application. Halogen lamps can be quoted for Brightfield applications.
2.	Page 23, Section Objectives. Are phase contrast objectives required for all magnifications?	Separate phase contrast objectives can be quoted for 4x, 10x, 20x and 60x magnifications as optional items.
3.	Page 24, Section Camera. Does the monochrome camera have to be a cooled device?	The monochrome camera should be a cooled device.
4.	For brightfield applications, what wattage should the halogen lamp have?	The halogen lamp should have a wattage of 100 W.
5.	Amendments to the technical specifications	60x objective, camera, controlling system and software are optional items and should be quoted as additional items.
