The goal of these technologies is to harness the properties of delicate superpositions, entanglement etc. possessed by quantum systems to develop quantum computers (computer which can solve problems at rate much faster than classical computers etc. ), sensors (magnetic fields for healthcare, tiny electric fields, global positioning, geological mapping etc), quantum encrypted communication systems, Atomic quantum clocks, quantum effects enabled devices and materials etc.
