1. Certificate regarding date of birth (Birth certificate / 10<sup>th</sup> certificate having DoB)
2. Mark sheet/s having final result & percentage and degree certificates of B.Com, M.Com and other relevant qualification/s as mentioned in the online application.
3. Certificate/s regarding experience/s as mentioned in the application
4. OBC Caste certificate, OBC-Non Creamy Layer Certificate (OBC-NCL) and Caste validity certificate (as applicable) issued by the competent authority valid as on date

5. No Objection Certificate (NOC) from the present employer, in case candidate is working in a government funded organization
