At the time of interview, applicants need to bring duly filled prescribed application form (available below advertisement link), self-attested photocopies of certificates in support of educational qualification, experience, date of birth and in support of information submitted in the application form and one recent passport size colour photograph (Pasted on application form).

**The applicant must also bring all the original certificates at the time of interview for the purpose of verification.**

### **General Information / details about the post**

1. Appointment is purely temporary and will terminate automatically without any notice or compensation on termination of the project.
2. The appointed person shall have no claim of appointment / absorption in Funding Agency or in IISER Pune.
3. Appointment of the applicant will be governed by the terms and conditions of the funding agency particularly applicable to the said project
4. The qualification prescribed should have been obtained from recognized Universities / Institutions.
5. Relaxation in requirement of qualification and/or experience may be considered in case of exceptionally meritorious applicants with the prior approval of the competent authority.
6. Age relaxation commensurate with educational qualification and experience of the applicant may be considered for candidates having qualification and experience higher than the advertised with the prior approval of the competent authority.
7. The prescribed educational qualifications are the bare minimum and mere possession of same does not entitle candidates to be considered in each stage of the selection process.
