Minimum educational Qualifications & Experience	Ph.D. in Science / Mathematics / Science Education with minimum 5 years' of relevant experience in the field of teacher training for school / college teachers. OR Post Graduate degree in Science / Mathematics / Science Education with minimum 10 years' of relevant experience in the field of teacher training for school/college teachers.
Preference	The candidate having following will be preferred: 1. Experience in working with school and college teachers on pedagogy and content development in the purview of teacher training. 2. Alignment with the philosophy of activity-based learning and hands-on approach to skill development and capacity building of teachers 3. Knowledge of education technology and technical writing. 4. Proficiency in either Hindi or any other regional languages in addition to English along with good command over oral and written communication skills
Job requirement	The incumbent is expected to lead a team of project fellows, technical officers, teaching associates and fellows to design and execute teacher-training workshops of the Science Activity Centre in Science and Mathematics for schoolteachers. Also, interact periodically with the head of the project management unit (PMU) and PMU (teacher training strand) on academic and non-academic aspects of the program. Though the job headquarters will be Pune, extensive travelling to different urban and rural areas across the country will be necessary.

Experience in training the school/college teachers in pedagogy and science and/or maths education. 2. School teaching experience with hands-on demonstrations and working with tinkering labs 3. Expertise in making educational videos and in handling different types of media. 4. Proficiency in either Hindi or any other regional language in addition to English with good command over oral and written communication skills
Job requirement	The incumbent is expected to assist in designing and executing teacher training workshops of the Science Activity Centre in science and mathematics. This includes creating content, designing models and hands-on activities that are related to but not bound by school curricula. While the job headquarters will be Pune, travelling to different urban and rural areas across the country will be necessary.

1. Duly filled prescribed application form (available below advertisement link)
2. All the originals and one set of self-attested photo copies of:
 - a. Certificate regarding date of birth
 - b. Mark sheets and certificates (starting from 10th onward) regarding educational qualification
 - c. All Certificate/s regarding experience/s as mentioned in the application form
 - d. One Photo Identity proof (Government issued)
3. One recent passport size colour photograph.

General Information / details about the posts

1. Appointment is purely temporary and will terminate automatically without any notice or compensation on termination of the project.
2. The appointed person shall have no claim of appointment / absorption in Funding Agency or in IISER Pune.
3. Appointment of the applicant will be governed by the terms and conditions of the funding agency particularly applicable to the said project
4. The qualification prescribed should have been obtained from recognized Universities / Institutions.
5. The prescribed educational qualification/s and / or experience/s are the bare minimum and mere possession of same does not entitle candidates to be considered for the interview. Where number of candidates appearing for walk-in interviews is large, it will not be convenient or possible to interview all eligible candidates. Based on the recommendations of the Screening Committee, the Project Investigator may restrict the number of candidates to be considered for the interview to a reasonable limit after taking into consideration qualifications and experience over and above the minimum prescribed in the advertisement. Therefore, it will be in the interest of the candidates, to mention all the qualifications and experience in the application.
6. Relaxation in requirement of relevant experience may be considered in case of exceptionally meritorious applicants with the prior approval of the competent authority.
7. Age relaxation commensurate with relevant experience of the applicant may be considered for candidates having experience higher than the advertised with the prior approval of the competent authority.
8. In case, a selected candidate does not join or resigns after joining the post, waitlisted candidate/s may be offered the position.
9. No TA/DA will be admissible for appearing for the interview.
10. No interim enquiries / correspondence / communication of any sort will be entertained on the matter.
11. Canvassing in any form and / or bringing any influence, political, or otherwise, will be treated as a disqualification for the post applied for.
